The official receiver shall, on the requisition of any creditor, summon a meeting for the purpose of filling any such vacancy. (3.) If the creditors do not within three weeks after the occurrence of a vacancy appoint a person to fill the vacancy, the official receiver shall report the matter to the Board of Trade, and the Board may appoint a trustee; but in such case the creditors or committee of inspection shall have the same power of appointing a trustee as in the case of a first appointment. The clause affecting the remuneration of the trustee is clause 72; the "majority required " is the majority of an " ordinary resolution," as denned in clause 168...
